Explanation of Responses:

- On January 18, 2023, the reporting person was granted an award of 6,552 Restricted Stock Units, which vests in three installments of 33%, 33% and 34% on the first, second and third anniversaries of the grant date.
- Restricted Stock Units convert into common stock on a one-for-one basis.
- Of the 2,162 Restricted Stock Units that vested, 894 were withheld and disposed of for taxes.
- On January 19, 2023, the reporting person was granted an award of 2,695 Restricted Stock Units, of which 1,078 vested on January 19, 2024 and 1,617 vested on January 19, 2025.
- Of the 1,617 Restricted Stock Units that vested, 669 were withheld and disposed of for taxes.
